The school feels that their score was lowered by several factors:

- Accelerated students did not qualify for a PARCC math assessment inhibiting growth
- Technical difficulties during testing
- Small school size
- Students rushing through in an "opt out" manner

Growth measures take into account how students perform compared to their peers in the state who have similar characteristics (prior performance, mobility, and attending schools of similar sizes and mobility rates). Therefore the only effect of excluding accelerated students is in the percent proficient, which accounts for only a tenth of the school's grade. Growth measures continue to be accurate and reliable measures of school performance.

The PED recognizes the challenges in transitioning to computer-based assessments. Therefore schools that utilized computer-based testing (CBT) received additional bonus points that were weighted by the proportion of a school's students tested by computer.

School grading uses statistical procedures [Value Added Modeling (VAM)] to accommodate for school size and therefore provides a more accurate and fair evaluation of small schools. Additionally, three years' worth of data is used for most indicators to provide a more accurate picture in a single year.

Federal law mandates "(ii) Not less than 95 percent of each group of students ... who are enrolled in the school are required to take the assessments, ...with accommodations, guidelines, and alternative assessments" While the PED is sympathetic with the variability of student motivation, it is incumbent upon the district and the school to plan proactively for such disruption and to ensure that students participate fully in assessments.

Participation would have been higher if students had not opted out of PARCC testing.

Federal law mandates "(ii) Not less than 95 percent of each group of students ... who are enrolled in the school are required to take the assessments, ...with accommodations, guidelines, and alternative assessments" While the PED is sympathetic with the variability of student motivation, it is incumbent upon the district and the school to plan proactively for such disruption and to ensure that students participate fully in assessments.

The PED believes that our expectations for schools to meet participation are fair-minded and more tolerant of anomalous circumstances than in the prior years of Adequate Yearly Progress (AYP). The PED calculates participation with three methods, including three-year averaging and then selects the method that most benefits the school. The methods are fair and impartial and are detailed in the School Grading Technical Guide, VI. Schools must meet participation in both reading and in math. Participation rates do not include examinees whose tests were exempted (medical or reading) or who withdrew before completion of the examination. Parental refusals and absentees are included in the total number of students that should have participated.

The school questions an atypical drop in proficiency that is not aligned with short cycle assessments. They request more timely access to student data that would help them verify accuracy.

The move to Common Core state standards necessitated a battery of new assessments aligned to these standards, including PARCC for regular education students and NCSC for students with severe cognitive impairments. These standards were known to be more rigorous than in prior years where New Mexico state standards were the yardstick, and thus a drop in proficiencies was anticipated and was realized by all states, not just New Mexico. We consider this a new baseline from which to progress in future years.

Because of this, the weighting of proficiencies in Current Standing was adjusted this year to account for the move to new assessments (see New Mexico ESEA Flexibility Request, December 8, 2015, page 78, "Reweighting of Selected School Components," http://ped.state.nm.us/skandera/waiver/index.html). The percent proficient was weighted only one third of the Current Standing points rather than two thirds as in prior years.

The alignment of short cycle assessments with the new Common Core State Standards has not been demonstrated and these assessments should not be used to predict student performance on PARCC. The state is working with other states to develop future interim PARCC assessments that may better serve this need.

A roster is being provided in SOAP that will allow schools to properly track their data and students. We regret that the timelines have been delayed because of this inaugural year of new assessments but the schedule will be back on track for this spring. If the school believes there continue to be unexplained discrepancies, the PED will honor an extension of this appeal for the school to provide further evidence.

Announcements will be made at school activities and events.

CHAPTER 12 PUBLIC SCHOOL ADMINISTRATION - HEALTH AND SAFETY PART 4 TOBACCO, ALCOHOL AND DRUG FREE SCHOOLS

6.12.4.1 ISSUING AGENCY: Public Education Department [6.12.4.1 NMAC - Rp, 6.12.4.1 NMAC, 12/15/2015]

6.12.4.2 SCOPE: This rule applies to school districts, local school boards and to state-chartered charter schools and governing bodies.

[6.12.4.2 NMAC - Rp, 6.12.4.2 NMAC, 12/15/2015]

6.12.4.3 STATUTORY AUTHORITY: This rule is promulgated by the secretary of public education and the public education department under the authority of Sections 9-24-8, 22-2-1, 22-2-2 and 22-5-4.4 NMSA 1978. [6.12.4.3 NMAC - Rp, 6.12.4.3 NMAC, 12/15/2015]

6.12.4.4 DURATION: Permanent [6.12.4.4 NMAC - Rp, 6.12.4.4 NMAC, 12/15/2015]

6.12.4.5 EFFECTIVE DATE: December 15, 2015, unless a later date is cited at the end of a section. [6.12.4.5 NMAC - Rp, 6.12.4.5 NMAC, xx/xx/2015]

6.12.4.6 OBJECTIVE: The objective of this rule is to prohibit the use, possession and distribution of tobacco products, e-cigarettes and nicotine liquid containers, alcoholic beverages, mood-altering substances and illicit drugs in school buildings, on school premises and by students at school-sponsored activities away from school grounds.

[6.12.4.6 NMAC - Rp, 6.12.4.6 NMAC, xx/xx/2015]

6.12.4.7 DEFINITIONS:

A. "Alcoholic beverage" means any beverage containing more than one-half percent alcohol by volume, and includes all distilled or rectified spirits, potable alcohol or any similar alcoholic beverages, including all fermented or blended beverages and dilutions or mixtures of one or more of these alcoholic beverages.

B. "E-cigarette":

(1) means any electronic oral device, whether composed of a heating element and battery or an electronic circuit, that provides a vapor of nicotine or any other substances the use or inhalation of which simulates smoking; and

(2) includes any such device, or any part of it, whether manufactured, distributed, marketed or sold as an e-cigarette, e-cigar, e-pipe or any other product, name or descriptor; but

(3) does not include any product regulated as a drug or device by the United States food and drug administration under the Federal Food, Drug, and Cosmetic Act, 21 U.S.C. Section 301 et seq.

C. "Illicit drugs" means prescription and over-the-counter medications used for non-medical purposes, or not used as medically prescribed by lawfully authorized practitioners or as directed by the manufacturer's literature, and include all supplemental dietary or nutrition ergogenic aids, stimulants, nootropics, adaptogens, painkillers, sedatives and anxiolytics, blood boosters and other performance-enhancing drugs.

D. "Mood-altering substances" means substances that change, or are capable of changing, a person's emotional state, and include all stimulants, opioids, intoxicative inhalants and hallucinogens.

E. "Nicotine liquid container" means a bottle or other container of any substance containing nicotine where the substance is sold, marketed or intended for use in an e-cigarette.

F. "School personnel" includes all administrators, principals, teachers, counselors, social workers, speech therapists, psychologists, nurses, librarians and other support staff who is employed by a school, or who perform services for the school on a contractual basis.

G. "Tobacco product" means any product made or derived from tobacco that is intended for human consumption, including any component, part or accessory of a tobacco product. This includes, among other products, cigarettes, cigars, pipe tobacco, roll-your-own tobacco, dissolvable tobacco, and smokeless tobacco. Smokeless tobacco means any snuff or chewing tobacco.

6.12.4.8 REQUIREMENTS: Each local school board or governing body shall establish a tobacco, alcohol and drug free school policy:

A. The policy shall provide specific rules of conduct prohibiting the use, possession and distribution of tobacco products, e-cigarettes and nicotine liquid containers, alcoholic beverages, mood-altering substances and illicit drugs in school buildings, on school premises and by students at school-sponsored activities away from school grounds.

B. Each school district and state-chartered charter school shall detail the prohibited acts and activities under the policy, and shall establish adequate provisions for its enforcement, including the enumeration of possible sanctions or disciplinary action, consistent with applicable statutory and case law.

C. The policy shall provide that no school employee who in good faith reports any known or suspected use, possession or distribution of alcoholic beverages, mood-altering substances or illicit drugs shall be held liable for any civil damages as a result of such report or efforts to enforce the policy.

D. Each school district and state-chartered charter school shall develop and implement a procedure for effectively communicating the policy to students, their parents and families, school personnel, visitors on school premises, and to local residents, groups, businesses and organizations served by the school.

E. Each school district and state-chartered charter school shall post conspicuous notices on all school premises prohibiting the use, possession and distribution of tobacco products, e-cigarettes and nicotine liquid containers, alcoholic beverages, mood-altering substances and illicit drugs, in school buildings, on school premises and by students at school-sponsored activities away from school grounds.

6.12.4.9 EXCEPTION: Sections 6 and 8 of this rule shall not include the lawful possession or use by a minor of a tobacco-cessation product approved by the United States food and drug administration.

Counselor's Corner

At present, eleven of fifteen seniors have been accepted to colleges/universities with several students gaining acceptance to multiple institutions. Information regarding the students is forthcoming with all students engaging in the application process to at least one post secondary program.

Prior to the break, students met with representatives from the University of New Mexico, UNM-Taos, the BA/MD Program (which is designed to increase the number of MD's in rural communities and throughout New Mexico), the United States Marine Corps, and the TRIO Program through Trinidad State Junior College and Colorado State University-Pueblo. Upcoming visits include representatives from Eastern New Mexico University, Colorado State University-Pueblo, and New Mexico State. Additional information is forthcoming.

Seventeen students obtained Dual Credit from Eastern New Mexico last semester with four students obtaining six credits and one student obtaining nine. Courses were taken onsite with Erica Roybal, who taught Dairy Science and Pamela Towry-Church, who taught Symphonic Band. Additional courses were taken on-line in subjects such as English Composition and Communication, which helps students fulfill General Education requirements regardless of the institution they will attend.

In addition, seven students obtained Dual-Credit from Luna Community College including Welding as taught by William McDowell on campus and the remaining students accessing on-line courses in Composition, Psychology, and Medical Terminology. It should be mentioned that two students obtained six credits during the first semester.

This semester there are seven students registered for on-line courses through ENMU where they are registered for between one to four college courses. In addition, there are five students enrolled in Dual credit courses where they will receive credit in Welding as taught by Mr. McDowell, and on-line courses including Psychology and Spanish for Medical Professionals.

In effort to help all of our seniors complete the Free Application for Federal Students Aid, we will be hosting a FAFSA completion event on February 17th from 2 to 4 P.M.

Students have been working diligently working on scholarship applications and participated in a special Senior Day on January 27th to help with specific needs they may have pertaining to college and scholarship applications.

NEW MEXICO HEALTH ALERT.

Influenza activity in New Mexico has been increasing. For the week of January 23rd, 2016 influenza like illness activity reported by sentinel outpatient provider sites in New Mexico for the 2015-16 influenza season exceeded the national baseline and also exceeded the level of activity reported for the week nationally. There have been 3 deaths related to influenza in the state of New Mexico and 50 pneumonia related deaths.

Drug-Free Schools

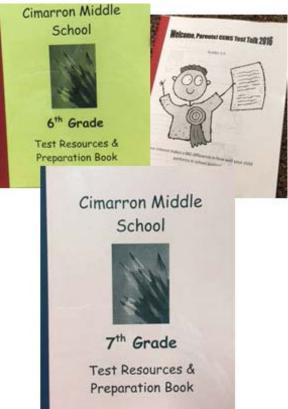
A major goal at Cimarron High School has been to have a drug free school. In the past, we noticed that students would come to school in the morning looking like they were under the influence. We put in a protocol that 1st period teachers (and any other period also) who noticed that students did not look normal would refer them to me and I in turn would refer to the nurse to do a check on the student. At one point, I had to make sure that Nurse Brazil started her day in Cimarron to assure that she was available to check students if need be.

Having teachers extra vigilant, being consistent with referrals, and having the nurse available to check and speak to students proved to be a major deterrent for drug use. Even though many times we couldn't prove that students were under the influence, just sending them to see the nurse sent a message. She would check them and we would both remind the student of the policy regarding drug use.

We continue to be vigilant but firmly believe that we have curbed drug use phenomenally. We have not had drug issues at CHS this year. In all areas of behavior, students at CEMS and CHS have been wonderful.

Test Talk Parent Night

CHS and CEMS will host a Test Talk Parent Night on February 11, 2016 beginning at 5:30. Teachers are doing a wonderful job gathering resources for parents. We will utilize this time to make sure parents understand the assessments their students take and to take time for parents to get their child's latest PARCC and Short Cycle Assessment reports. We are also going to provide access to computers so parents can see practice PARCC items and know what their children are expected to do.
