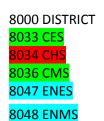

2nd graders are almost finished writing books about the human body. They have learned about their skeletal system, heart, lungs, brain, and the five senses.

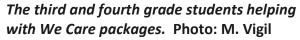
2nd graders researched and wrote paragraphs about how they were named. They enjoyed talking to their families about their unique names.

Fall sports seasons are behind us and basketball is underway. The first big tournament is the Cowbell and both the Lady Rams and Rams are participating. We continue to struggle with low numbers in girls' basketball and there is concern that Eagle Nest does not have a girls' basketball program. Boys' numbers continue to be good with participating in middle school, JV and Varsity.

Principal Pieces

We continue to work with students to create a hybrid teaching environment. We started with IDEAL NM and proved to have many challenges. Some staff and principal toured Taos Academy to see their program, and the data (PARCC Assessments) show that they are successful with their on-line curriculum, Edgenuity. We will be piloting Edgenuity this spring with our students who are interested. Teachers are excited about this opportunity because it gives them more autonomy with the course.

I just finished my first go round of the staff's observation. I started on November the 7th and finished last Friday. I did it different this year. Always in the past, to accommodate multiple principals, we would observe all the teachers and then I would discuss the lesson with the teachers. (This lead to a long wait time from observation to discussion.) As time goes on you evolve plans; I like where the school is now. I would watch the teachers in a family on the same week, and then on Thursday of that week go over the lesson with the individual teachers. This was much better because the wait time was eliminated, the discussions were healthier, and I didn't feel under a rush to get all the teachers done in one day. It even leads to more creative lessons; I had two mid school teachers tie their lessons together.

For the midyear check I like where the school is. The mid school seems to be more consistent, creative, and all on the same page. They are a much more cohesive team. We have a creative and internal ELA tutoring program at 1:30, and we will create the same for math.

I was very pleased with the depth of teaching in 3-5. Having fewer students in a class has created a better learning environment. We are able to meet more students' needs thus creating more teaching time. What a difference to go from class sizes of 31, 28, and 20 to class sizes of 19, 17, 17, and 17. Thank you very much for the additional teacher. What a difference it has made. I have no doubt the children are benefiting.

The K-2 family lost strong teachers who transferred into upper grades. Last May I was wondering if those shoes could be filled and they were. We all have different strengths and weaknesses, and it is how a team uses those qualities for growth that is important. The k-2 family hasn't missed a beat.

For the most part the children are happy and eager to learn. The mid school children are excited about Trail End Ranch. They made a flag for the ranch because they wanted to mark "their" ranch. During lunch some of the boys and I go over different maps in order to create our own trail system to those, as of yet, undiscovered caves.

I am always trying to find different motivators for the children. I have two interesting statistics from the horse program: two mid school girls are working a week ahead in a math/ computer class so they can have an additional 45 minutes with the horses. A boy that was being disrespectful was willing to improve his behavior in order to have horse time. This young man has given us seven consecutive weeks of good behavior.

A month and a half ago the teachers started a consistent approach, k-8, in addressing our writing concerns. This past Friday we went over the Parcc results and found the top ten 'weak" areas that need coverage in both ELA and math. I believe we came up with a comprehensive and creative approach to address these areas.
