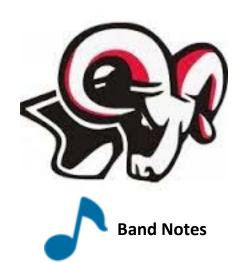

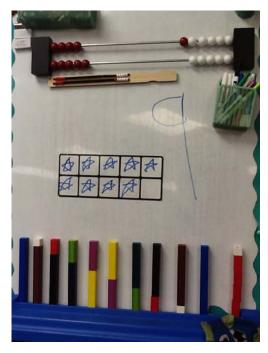

#### Third Grade, Mindy Vigil

3rd graders are researching the decades of the 60s, 70s, 80s, and 90s, for an informative essay in Language Arts. Each student chose a decade to research, and will compile information into a display, as well as a short informative essay. So far, they've watched short videos on the History Channel about each decade, and have interviewed someone in their family about the decade they chose. Next, students will be interviewing different staff members. We've shared some good laughs about past hair and clothing styles; we've been sad to find out that the 60s were so turbulent; and, it's been very interesting to find out what school was like in these past decades!

#### **Fourth Grade, Leo Martinez**

Math- students are learning about decimal place value, comparing and ordering decimals, and reviewing fall semester standards.

Science-studying the solar system, reason for seasons, phases of the moon, and stars.

Social Studies- completed study of Northeast Region.

LA-reviewing phonics, and phonemic awareness, writing to various prompts.

#### Middle School, Carl Seward

5th grade ELA- Just finished learning 14 new vocab words and are beginning to learn how to analyze a grade level text and then create their own rigorous critical thinking questions.

6th grade ELA- Just finished learning several poetic concepts (alliteration, onomatopoeia, similes, etc.) and creating their own poems and are now reading literary text with a focus on the unreliable narrator as a literary device.

7th grade ELA - Just finished reading an African folktale and presenting to the class general folktale elements as well as the setting, conflict, and resolution of the story. Next they will read a short memoir while making accurate annotations as well as defining several vocab words using only context clues.

8th grade ELA - Just finished learning literary elements of a horror story (suspense, foreshadowing, description, etc.) and creating their own original ending to the "Tell-tale Heart." They are now comparing two versions of a literary text while analyzing the meaningful differences, similarities and purposes of each version.

#### **Counselor's Corner**

We currently have 13 students that are enrolled in Dual Credit courses through Eastern New Mexico University in classes including Introduction to Psychology, Sociology, English Composition, Theatre, Anthropology, and Music Appreciation. In addition, we have two additional students taking Dual Credit courses from Luna Community College in Developmental Lifespan Psychology, Nutrition, and Medical Terminology. There are also two seniors who are enrolled in an Emergency Medical Technician coursework through the University of New Mexico.

Students are actively working on scholarship and college applications with several receiving letters of acceptance from Regis University, Colorado State University-Pueblo, Eastern New Mexico University, New Mexico Highlands University, Trinidad State, and Luna Community College.

Cimarron High School students struggled first semester with IDEAL NM courses. We are moving to a different hybrid environment, piloting Edgenuity with the help of our tech team. We are hoping for challenge and rigor and greater support during second semester.

#### **Athletics**

Basketball is underway. Lady Rams are at the top of the district. Rams are 3<sup>rd</sup>. Baseball and Track practice start dates are right around the corner.

### **Principal Pieces**

Two teachers, Ms. Cox and Ms. Airington were instrumental in getting support and putting a ski/snowboarding club together, k-12. Cimarron students enjoyed the opportunity to experience skiing/snowboarding with support from the school.

The Cimarron Schools Ski and Snowboard club is made up of students from the ages 6-18. They have travelled twice to the Red River Ski area and will travel two more times in February. Students are divided into groups based on skills and age. Each time they attend, they advance in skills and confidence. Students take

90-minute lessons from snowboarding. Even advanced





instructors for both skiing and kids are able to learn from advanced coaches to improve their techniques. Many children who are usually very quiet and reserved in the classroom have attended and broken out of their "shells" and come to life during their trips. Many parents have also expressed their gratitude for the school providing such an exciting opportunity for their children. We look forward to continuing to grow this program and are very grateful for support from Ms. Martinez who provided travel funds from the activity accounts.

Cimarron Elementary has a grant called Results Driven Accountability (RDA). A team from NMPED does fall and spring site visits and create a report to show areas of need at our school. Two areas of need emerged, Data Driven Accountability and Parent Involvement. So we did some hard work to improve in these areas. First, we built our 90-day plan around Data Driven Accountability and are working hard to use data to drive instruction, to identify students and their areas of need for improvement, and to create and Teacher Action Plans to address these needs and to prepare our students for PARCC. Teachers are meeting in weekly PLC (Professional Learning Communities) to do this continuing work.

Although we have had advisory parent groups and some parent meetings, at Cimarron Elementary we had a defunct parent group called VIPs (Very Important Parents). After the fall visit, I worked hard to contact parents to form a strong and viable parent group. With support from staff and some amazing parents we are on our way.

#### **Parent Participation**

HALOS, our newly renamed parent group, was formed in November. It was established to help with different projects to support the RDA Grant such as library night, math night, and reading night, but also with the understanding that parents would bring their support and needs to create a strong school/community bond. The group had a great turnout of parent volunteers at the first meeting and has had on average 8 -10

people attending the meetings since then. The group wanted to name themselves HALOS (Helping and Leading Our Schools) with the purpose of getting not only parent involvement, but the community as well. Right now the group is mostly focusing on the elementary/middle school, but plans to start extended its



focus to the high school. Their first fundraising event, Polar Express Family Movie Night, had over 100 people attend with great feedback from the community wanting more movie nights. Another fundraiser was at homecoming selling cotton candy and running a baseball game. The group has on its calendar Family Reading Night, Family Math Night, a 5K/obstacle course fundraiser, supporting PARCC testing at the elementary, middle, and high school, a communications committee, and a possible movie night for Mother's Day.

- Maxwell and Cimarron will co-op for two years--2016 and 2017 and 2017-2018.
- Cimarron will be responsible for providing uniforms.
- Cimarron will provide Maxwell the opportunity to host two home games during thhe season at Maxwell provided baseball field is acceptable for play under NFHS/NMAA Regulations
