Cimarron Municipal Schools Proposal for Architectural Services.

January 2nd, 2017 Mr. Adan Estrada Superintendant Cimarron Municipal Schools

Mr. Estrada,

Thank You for including us in your request for Architectural Services that we received by e-mail on December 16th, 2016. Living Designs Group Architects has had the pleasure to assist the Cimarron School District through the process of consolidation and programming for this project, and we have an intimate understanding of the task at hand.

We look forward to assisting Cimarron Municipal Schools through completion of the vision. This is great opportunity to help establish a bright future for the school district. As per the invitation – we understand the terms of the contract to be PSFA's General Conditions of Agreement between the Owner and Design Professional 2010 Edition, Version 3.1.

Project Summary: The Cimarron Schools 2.8 million dollar renovation projects will require the architect, in conjunction with the owner, to reduce the square footage of the facilities occupied by the district through creative programming and cooperation with the administration and staff.

LDG Architects Proposes the following steps as a road map towards completion of the project. Those steps include the following:

1) Documentation of Existing Conditions.

The architect's team will need to thoroughly document the existing facilities. That will be accomplished by measuring and drawing the existing buildings, documenting their electrical and mechanical systems, and completing a set of as built documents to base the renovation documents from. This will allow the owner and the contractor to thoroughly understand the scope of the renovation project for pricing and scheduling purposes.

2) Schematic Design.

The project team will consist of administration, staff, and key members of the community. This Facilities Team, along with the Architect's team of staff and engineers, will generate a Schematic Design that is built on the programming to date. That Schematic Design will document the scope of the renovated spaces, the preliminary budget for construction, and the project timeline. Schematic Design will also establish the sequence of operations to assure student safety and minimal disruption to classroom instruction and campus function.

3) Design Development.

After the project team has had time to distribute and gain feedback from the Schematic Design Documents, the team will incorporate that feedback, and generate design development documents. Those documents will begin to establish the scope of construction in detail and the development of any systems required by the project. Systems include building and construction systems like mechanical (HVAC), plumbing, electrical, architectural and structural. Systems also include security, data and IT, signage, life safety systems, and communication systems.

4) Construction Documents.

Based on the approved Design Development Documents, the team will develop final Construction Documents that will be used to bid and construct the project. The Construction Documents will be a series of drawings, a project manual, and any models or addenda that are issued during bidding. The final Construction Documents are the detailed architectural drawings, and drawings that are coordinated and supplied by the architects engineering consultants such as mechanical, electrical, and plumbing documents.

5) Bidding and Negotiation.

The final Construction Documents that are approved by the district will be distributed by an Invitation to Bid. The Architects team will assist the district in bidding process. That Bid process may be a Request for Bids (RFB), or a Request for Proposals (RFP). The Architects team will assist the district in formatting the process that suits the district best, completing the bidding process, and awarding the contract for construction. For the sake of this proposal, LDG Architects assumes one set of documents, bid and awarded to one contractor. However, if during the process, LDG and the owner see an advantage to construct the project under a small number of individual contractors, the project team may decide to pursue that path and negotiate terms for a number of bid packages, and the administration of multiple contractors.

6) Contract Administration

Once the contract is awarded, The Architects Team will assist the district in the administration of the Contract Documents. That administration includes project meetings, site visits, issuing of additional direction, clarification of construction issues as they arise, and closeout of the project with final completion, punch list coordination, and final warranty walkthrough.

Project Scope:

- 1. Document Existing Conditions.
- 2. Schematic Design.
- 3. Design Development.
- 4. Construction Documents.
- 5. Bidding and Negotiation.
- 6. Contract Administration.
- 7. Closeout.

<u>Proposed Compensation:</u> Based on the Professional Fee Schedule attached to the request, the proposed project would be classified as an Above Average Project, one that is comprised of a Major Renovation with Mechanical System replacement or upgrades.

According to that Professional Fee Schedule, a project with a 2.8 million dollar MACC extrapolates to 7.6% fee (IE a fee of \$212,800)

As a CES vendor, and as an experienced provider of services to the Cimarron School District, Living Designs Group Architects would like to extend a discount to the school district.

Living Designs Group Architects would like to propose a fee of 7.1% (\$IE a fee of \$198,800), That is discount of .05 % of the project MACC, (ie a discount of \$14,000). The fee stated is inclusive of the entire scope of services listed above.

Not included in that fee is NMGRT (gross receipts tax) and reimbursable expenses. NMGRT will be added to each invoice as services are completed and billed for. Reimbursable Expenses are for printing, mailing, and associated project expenses. LDG Architects will not charge Cimarron Schools for mileage and driving time to and from the project. LDG Architects proposes an allowance of 4% of the project fee for Reimbursable Expenses.

Addendum A - 2017 General Terms and Conditions is attached and understood to be binding to this proposal and contract if accepted.

Addendum A - 2017 SCHEDULE OF FEES AND **GENERAL TERMS AND CONDITIONS**

This schedule describes Living Designs Group Architects compensation and terms for professional services. Cost estimates are valid for 30 days from the date of the proposal, unless an alternate period is specified herein. Acceptance of a proposal by the Client constitutes a valid and binding contract subject to the following terms and conditions.

2.0 FEES (Time and Expenses)

2.1 Hourly Rates

Staff

Charges for any services performed at or on Client's behalf will be based on the following hourly rates for the various classes of personnel which Living Designs Group may assign to the project.

HOURLY RATE, \$ PERSONNEL CLASSIFICATION Architects 150

93 Increased hourly rates may be charged for litigation support services and expert testimony and shall be negotiated by the parties prior to rendering these services.

Living Design Group's hourly rates include overhead and profit. Out of pocket expenses such as travel, subsistence, long distance telephone, reproduction, computer time, equipment rental, and subcontractor charges are invoiced at Living Designs Group's cost plus a 15% service fee to cover insurance and accounting costs.

2.2 Invoicing and Payment

Invoices are submitted monthly and contain a description of work performed, a list of personnel and time expended by each person, and a detailed list of reimbursable expenses, in accordance with generally accepted accounting principles. All services and design requirements are based on local and state criteria in effect on the date of this Agreement and do not include extra services not specifically listed. Special design, extra services, offsite work, Client and architectural revisions, and revisions due to changes in governmental policy will be billed at our current hourly rates. Execution of this agreement indicates acceptance of all terms and responsibility for payment.

2.3 Payment Terms

Invoices are due upon receipt. Unpaid balances at time of subsequent billing are subject to a late charge of 1.5% per month until paid. Notwithstanding such provision for the payment of interest, in the event any invoice remains unpaid for a period of 60 days, Living Designs Group shall have the right to withhold its project deliverables, stop rendering services and treat the contract as having been breached by the Client. Invoices shall be considered correct and payable unless questions or issues as to invoice items or amounts are directed to Living Designs Group in writing upon receipt of invoice, and no later than 10 days after.

2.4 Costs of Collection

In the event that Living Designs Group brings an action to recover any amounts due to Living Designs Group, Living Designs Group shall be entitled to recover any costs, including legal fees, incurred in such proceeding.

2.5 GENERAL TERMS AND CONDITIONS

2.6 Standard of Care

Living Designs Group's services will be performed in a manner consistent with the degree of care and skill ordinary exercised by members of the same profession currently practicing under similar circumstances. LIVING DESIGNS GROUP PROVIDES NO WARRANTY, EITHER EXPRESSED OR IMPLIED OR GUARANTEES REGARDING ITS SERVICES.

2.7 Insurance

Living Designs Group shall maintain policies for Professional Liability, General Liability, Automobile Liability and Worker Compensation. Insurance certificates will be furnished upon request.

2.8 Allocation of Liability

Client agrees that Living Designs Group's liability to client (including liability under law to indemnify Client) shall not exceed Living Designs Group's fees hereunder.

2.9 Site Access and Security

Unless specifically agreed otherwise, Client is responsible for obtaining permission from any property owners for access or use of their property and Client shall obtain written authorizations allowing Living Designs Group to enter and use properly as necessary in providing Services. Living Designs Group will not enter property belonging to any third party unless Client has secured written permission from the Owner and Client has agreed in writing to be

responsible for and hold Living Designs Group harmless from any claims arising from property damage caused by Living Designs Group's services, except where such damage can be shown to be caused by Living Designs Group's sole negligence.

2.10 Conditions of Service

Living Designs Group relies on the approval by the reviewing agencies of drawings, reports, permits and other final submittals, etc. as evidence of compliance with all applicable ordinances, regulations and design standards. Living Designs Group shall be held harmless from any change in interpretation after receipt of any approvals and the revocation of approvals for any reason. Except as specifically provided in the scope of services hereunder, Living Designs Group is not responsible for determining any law, regulation or ordinance with which Client must comply for approval or completion of Client's project. Moreover, any assistance provided in this regard shall not be construed in any way as advice of counsel.

2.11 Obligations of Client

Client shall be responsible for coordination with all consultants or work forces hired directly by Client and all governmental agencies as warranted. Client shall furnish all legal, accounting and insurance consulting services as may be necessary at any time for the Project, including auditing services. Client shall furnish information specified in the Scope of Services and shall render approvals and decisions as expeditiously as necessary for the orderly progress of Living Designs Group's services. Client agrees to pay any taxes, including personal property taxes, imposed on or resulting from the professional services provided by Living Designs Group (excludes income taxes imposed on Living Designs Group's net income).

2.12 Termination

This Agreement may be terminated by either party at any time upon thirty (30) days prior written notice to the other parties. Upon termination, Client shall pay all monies owed under the Agreement for all work performed up to the effective date of termination, plus any applicable termination costs.

2.13 Use of Living Designs Group's Information

2.16 Miscellaneous

All services to be performed by Living Designs Group under this Agreement are intended solely for Client's benefit. Nothing contained herein shall confer any rights upon or create any duties on the part of Living Designs Group toward any person or persons not a party to the Agreement including, but not limited to any contractor, subcontractor, supplier, or the agents, officers, employees, insurers, or sureties of any of them. Living Designs Group shall not be responsible for hiring, firing or supervision of the contractor, its employees, subcontractors or agents nor for the means, methods, procedures, techniques or sequences of construction, nor for the safety on the job site, nor shall Living Designs Group be responsible for the contractor's failure to carry on the work in accordance with contract documents. Living Designs Group shall not be liable for any delay charges.

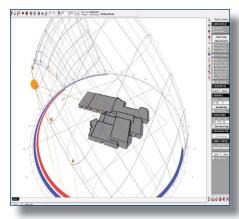

The facility provides a permanent home for students in the District's home school program.

Students attend the program half time, and spend the other half being instructed from home.

With two sessions, the school is used in a full-time capacity. Students are taught both in whole group instruction as well as in smaller break-out groups. Because of the multiple sessions and the varying group sizes, flexibility was a major concern for the Family School.

Flexibility was implemented in the design of all of the learning spaces to maximize the use of the facility. This carries through in the sizes and shapes of the classrooms, the arrangement of the spaces as well as utilization of outdoor spaces as learning environments which can be opened up from anywhere in the school.

Vigil&Associatesworked closely with the building committee throughout the design process to develop concepts for the building based on the educational program and the open learning environment the faculty envisioned. The result of the design effort is a courtyard building, utilizing outdoor circulation space which can double as an outdoor learning environment in the favorable arid Belen climate.

Important design considerations included the ability for a small staff to observe most of the spaces in the school from their own area, orienting the building to take advantage of solar orientation, shielding outdoor areas from westerly winter winds.

Provision for future classroom wings, designing a facility which is unique to the community and that works well within the context of the site and program were emphasized.

Budget was a primary concern from the onset. Vigil & Associates worked towards designing a facility to both maximize, and to be innovative with every space. The design, which utilizes exterior circulation to save square footage as well as implements a carefully chosen palate of materials and methods of construction, creates a special facility for the Family School for many years to come.

The renovation and replacement of the Aspen Elementary School was designed to be a high-performance, student-centered facility. It has an Energy Star Rating of 89 and incorporates sustainable strategies such as natural daylighting with thermal massing to provide passive solar heating to reduce energy consumption by 35% or \$29,000 annually.

Project Phasing / Maintaining operation during construction and renovation:
A large portion of the existing facility was occupied during construction, which necessitated a two-phased construction process.

A temporary campus accommodated the displaced functions and allowed the contractor full access to the construction areas while providing students and staff safe passage to the operational building areas.

Integrated classroom technology: The design is a culmination of the design committee's vision and displaying new high-performance design features. It offers space for conventional and flexible teaching and integrate leading edge classroom technology. The entire school will be a "Teaching Tool" for the students.

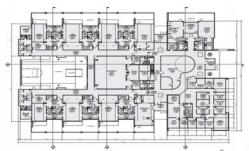

The proposed Intensive Support Program Hub facilities will house severely handicapped students who have been determined not suitable for mainstreaming. Candidates for mainstreaming will places within existing programs integrated within various campuses. The current plan is to locate a regional Intensive Support Program Hub in each of the four quadrants of the District.

These facilities will be run by the APS Special Education Department and not by the affiliated school themselves. Planning efforts for the buildings on particular campuses will focus on integration as much as possible so that these facilities weave into the fabric of the school environment and are not isolated structures.

Currently the project is on hold for future funding.

COLLET PARK ELEMENTARY RENOVATION: NEW KINDERGARTEN BUILDING ADDITION



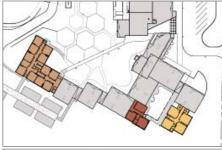

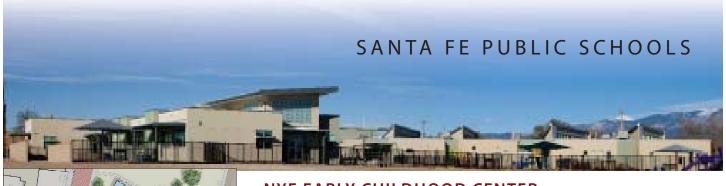

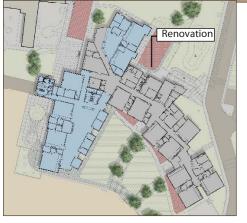

The Nye Early Childhood Center is a preschool for special-needs (autistic, medically fragile) children and typical peers. It was located within an elementary school, but the need for expansion of both programs required it to be moved off site. Vigil & Associates worked closely with Santa Fe Public Schools to design a new facility using an existing school site.

The new Nye Center included a large classroom wing addition, 2 indoor play spaces, multipurpose room, physical therapy suite, therapy offices, administration and staff areas, warming kitchen and support spaces. Tséhootsooí Elementary School reflects care and respect of the local Navajo culture throughout the complex in the use of both color and design elements. The school consists of ten classrooms, a new multi-purpose room, and renovation of the existing kitchen. V&A teamed with a local Native American cultural design consultant for this project. New rooms were added for tutoring, research and computers, and existing spaces were expanded to accommodate a new librarian's office, circulation desk and story corner. 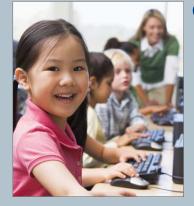

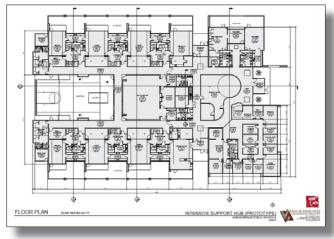

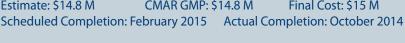

The Bandelier Elementary project provided a larger kitchen and cafeteria for the school, a new technology lab and small addition to the media center. 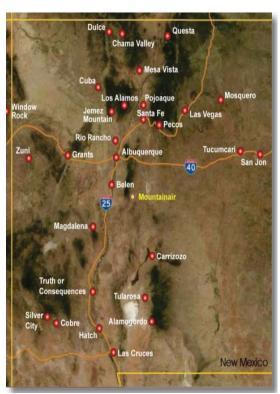

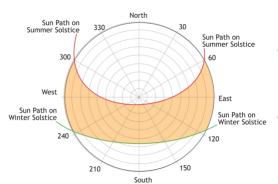

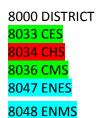

New Mexico School Boards Association Board Vacancy Statute & Options for Filling Vacancies

New Mexico State Statute

22-5-9. Local school board vacancies.

- A. A vacancy occurring in the membership of a local school board shall be filled at an open meeting at which a quorum of the membership is present, by a majority vote of the remaining members appointing a qualified person to fill the vacancy.
- B. A qualified person appointed to fill a vacancy occurring in the membership of a local school board shall hold that office until the next regular school district election when an election shall be held to fill the vacancy for the unexpired term.
- C. If a qualified person is not appointed to fill the vacancy within forty-five days from the date the vacancy occurred, the state board [department] shall appoint a qualified person to fill the vacancy until the next regular school district election.
- D. In the event vacancies occur in a majority of the full membership of a local school board, the state board [department] shall appoint qualified persons to fill the vacancies. Those persons appointed shall hold office until the next regular or special school district election when an election shall be held to fill the vacancies for the unexpired terms.

II. Options for Filling a School Board Vacancy

These are <u>possible</u> options to consider in filling a school board vacancy. Keep in mind the only requirements are those stated in the law.

- Board establishes timeline for board member selection. (Remember you have 45 days from the date of the resignation to fill the vacancy. If board does not fill the vacancy in that period the Secretary of Education fills the vacancy)
- 2. Board issues Notice of Vacancy to the public (suggest paid ad/letter in newspaper) which includes:
 - a. qualifications (registered voter / resident of school district or resident of board district if districted)
 - b. required documents such as letter of interest, resume, request to answer questions (why interested, etc.)
 - c. deadline for receipt of letters of interest.

- 3. Board accepts letters of interest, resumes, etc.
- 4. Board reviews information and determines eligibility.
- 5. Board determines if applicants will be interviewed or not.
- 6. If necessary interview schedule is prepared
- 7. Board conducts interviews
- 8. Board decides if community groups will participate in the interviews. (eg. PTA, Chamber of Commerce) or not.
- Board discusses applicants and selects replacement in open meeting by majority vote
- 10. Board advises Secretary of Education and NMSBA that vacancy has been filled.

Please remember ALL discussions and actions by the board must be in an open public meeting properly advertised. None of the discussion relating to replacement of a board member may take place in executive session or outside a board meeting via phone or private meetings. Also keep in mind there is no requirement for advertising the vacancy, interviews or involvement of other groups. These are merely options you may want to consider.
