

REMOTE LEARNING

Schedule

August 12th to September 4th

Due to the governor's newest order that requires all New Mexico schools to either delay start until September 8 OR start REMOTE LEARNING through September 8. Cimarron Municipal Schools will do Remote Learning, starting on August 12. During REMOTE LEARNING, students' needs will be prioritized to identify the small groups of students that will be able to come to the school. Parent decisions to allow students to learn online will be honored. School hours will be 9:00am to 3:00pm Tuesday through Friday. Teacher office hours are from 3:00 to 4:00. Transportation will be provided for students identified to come to school on site. Meals will be offered to all onsite students and available for pickup for online students. Meals will NOT be FREE to ALL and instead will follow the regular USDA requirements for payment unless students fill out the applications and meet the income guidelines established by the program.

August 12-14

Cimarron Schools will begin Remote Learning. All students PreK-12th will be scheduled to come to school **one full day** during the first partial week of instruction. Students who will be working from home will be encouraged to come to school on their scheduled day. All COVID protections will be in place, masks or shields must be worn, social distancing followed and thorough hand washing and disinfecting will be required.

Bus available by request only for the first week. Call Liz at bus barn 376-2401 or cell 575-477-2010 to get pickup location and time. Teachers will contact parents to identify what day their child will come into school. Teachers will only be able to accommodate up to 5 students. During this first week teachers will do orientation activities with students to build trust, communication and camaraderie amongst the new class. Teachers will also assess student's academic levels and train students on how to work remotely from home. Teachers will compile students passwords, classroom expectations and will explain new onsite COVID safety measures for students.

Teachers will use assessment, communication with parents, and prior teacher recommendations to identify the 5 students that will be identified to come back the following week for onsite instruction. If your child is selected to come onsite, it is highly recommended for you to consider your child's need in determining an onsite or online work platform. Parent decisions will be honored.

Aug. 18th to 21st

During the first week of concurrent sessions, students will be working together with the teacher and up to 5 identified students onsite. All other students will be working from home while participating virtually. The use of a camera and microphone will be required and is available within the student's school provided chromebook or parent provided device. Students will be considered present by attending class onsite or online during live instruction. If a student is not

able to attend live instruction, class will be recorded and students will have access to the recording. However, they will be counted absent for attendance purposes.

Aug. 24th to 28th

This year, students will be allowed to participate in “Monday School.” Participants will be selected based on academic need. The first Monday School will be August 24, 2020. The students that are identified for onsite classes will not necessarily be identified for “Monday School.” Teachers will contact parents by Thursday of the prior week to recommend attendance on Monday and identify specific student needs. Cimarron Schools highly recommends that parents accept student invitations for student onsite participation. Transportation and meals will be provided.

All students will be able to use the 3:00-4:00 teacher office hours for any needed help. Teachers will also be checking and responding to email during this time. If questions arise, please be aware that teachers will not be required to respond until these established office hours. Any questions received after 4:00 will not be addressed until the next day. This will give teachers uninterrupted classroom instruction. Please limit communication to email and phone calls during office hours.

Sept. 1st to 4th

During the third week of concurrent classes, students should be developing a routine. If parents or students have any questions please use teacher office hours to get questions answered. Parents should make arrangements and identify if their child will continue onsite or online. This will be required for all elementary school students Pre-K to 4th grade. Tentatively, this is the last week for REMOTE learning for elementary. Pre-K to 4th grade will then be allowed to enter the HYBRID learning model the following week. (Depending on Governor’s Determination of Safety)

Sept. 8th-11th

This is the first week for HYBRID learning, full classrooms for elementary students PreK-4th, all other grades will continue REMOTE learning with 5:1 teacher ratio.

Middle school students grades are tentatively projected to reenter to HYBRID status September 22nd and High School October 6th. These dates are assumed and will not be official until the Governor’s approval.
